

# Consistory Meeting Minutes - St. Paul's UCC, Sheboygan, WI Wednesday, December 14, 2016 at 7:00 p.m.

Treasurer's Report and Stewardship Report for November (Linda Mueller): Linda reviewed the reports. Total Income: \$8,344. Total expense: \$7,564. Net Income: \$779. Building Improvement Fund: \$31,017. Parsonage Fund: \$32,701. General Fund: MINUS \$(11,972.) Memorial Fund: \$95,857. Other assets: 573 shares Heartland Financial: \$17,969. Stewardship Report Weekly Giving total: \$7,527.

- Second Mile donations totals received amounted to \$1,070, not enough to significantly reduce the deficit.
- No documentation or notarization received thus far for the Land Contract negotiated a year ago.
- Significant increase in the attendance count for November, 2016 (106 more attending than November, 2015)

#### **Head Trustee Report (Jay Englebert & Mason White):**

- The mail slot box at the west side entrance will be moved inside for better security at a cost of \$500.
- The fence and fence poles have been removed at a cost of \$100.
- Installing gutter guard for leaf control on the garage and the north side of the church building and caulking of windows delayed until a spring thaw occurs, but the garage door repair may proceed without delay.
- The snow plowers (Wagner's) have been asked and agreed to the request to push the snow at selected spots away from the marked parking spaces in the lot.

#### **Board of Christian Education Report (Lisa McKenzie):**

- Christmas Play performance on December 4 progressed well.
- Valentine's Day party with parents' night out planned.
- Our Family in Need church mission done with and through the Salvation Army's Adopt-a-Family Mission completed on December 18. All the donations to this mission will be delivered to the Salvation Army to give to the family.

#### Pastor's Report (Jeremy Hylen):

- Jeremy Hylen, our Pastor and Teacher, has been selected to represent the Wisconsin Conference at the UCC Synod.
- Work in progress on the new pictorial directory. Picture taking starting on January 8 for a month in the Community Room.
- "The Last Supper" drama will be held on April 2 at St. Paul's, a possible cooperative effort by St. Paul's, St. John's, Ebenezer and First Congregational UCC churches.
- Jeremy handed out copies of The Parish Paper article on church anxiety and the SHIFT article on the "Five Practices of Fruitful Congregations." Jeremy said he recommends involving in SHIFT church members not heavily active in other ministries. The SHIFT focuses on strengthening ministries and church renewal.
- The sound system needs to be looked at.
- Furniture in the Gathering Room is being rearranged, removing the pews, adding other furniture.
- The record-keeping and dissemination of information on funds and accounts of some church committees or groups needs to be improved.
- A coalition of churches, including St. Paul's and St. John's, running a warming shelter at Salvation Army from January 1 through February 31, caring for people needing to keep warm in the community.

#### President's Report (Richard Reineking):

- Richard emphasized the date for the Annual Congregational Meeting (January 22 tentative).
- Work in progress on the digital message board and removal of the flag poles located on each side of the message board. Completion expected within five weeks.

#### **Other Business:**

- State inspection of the boiler was done Dec. 20, 2016.
- Charlotte Jump said the Endowment Committee is reviewing investment options on the Endowment monies.
