# Consistory Meeting Minutes - St. Paul's UCC, Sheboygan, WI Wednesday, April 12, 2017 at 7:00 p.m.

Treasurer's Report and Stewardship Report for March (Linda Mueller): Linda reviewed the reports.

Total Income: \$7,427. Total expense: \$14,827. Net Income: \$-7,400. Building Improvement Fund: \$29,721. Parsonage Fund: \$24,433. General Fund: \$-14,504. Memorial Fund Savings Account: \$95,872.

Other assets: 573 shares Heartland Financial: \$27,504. Stewardship Report Weekly Giving total: \$7,073.

- The Utilities cost for Internet & Phone increased by a small amount.
- The cost for the digital message sign, cable, and electric bill amounted to \$21,987. Question raised on sponsoring fundraisers for the digital message sign. Two fundraising brat fry events for the General Fund are already scheduled for this year.
- The Land Contract change in process of being signed and notarized.
- A request is being made of the Endowment Committee to cover the cost of the Last Supper dramatization from the Endowment Fund. Total cost of the drama production amounted to \$1,049 (lights rental \$550, programming \$360, window covering \$97, and other miscellaneous expenses).

# **Board of Christian Education Report (Jaymz Stempihar):**

- No report.
- Jeremy Hylen stated: Carnival scheduled for June 11; reviewing Sunday school curriculum at next meeting; considering doing Vacation Bible School (VBS) with Ebenezer and First Congregational UCC churches at Ebenezer UCC church (alternative: family nights)

#### Pastor's Report (Jeremy Hylen):

- New blue paraments received for the Advent season.
- Wisconsin Conference Annual Meeting at Green Lake Conference Center, June 8-11. Jeremy is a delegate to General Synod meeting in July.
- Piano in Sunday school classroom with broken parts to be discarded. The pianos in Friendship Hall and in the sanctuary are in satisfactory condition and should be tuned every six months.
- This is the 500th year of the Reformation, and a celebration by the Sheboygan UCC churches is being considered.
- Summer worship at Sheboygan's Veteran's Park on Sunday, July 23.
- Using a sturdier table for communion instead of the folding table is being considered.
- Member recognition on Pentecost Sunday, June 4.
- Garage clean-up: water leakage caused rotting wood and other damage.
- Dedication of the new digital message sign board forthcoming.
- Renovating the Memorial Garden with raised garden boxes and flower planters.

# President's Report (Richard Reineking):

- Richard thanked everyone for helping with the Last Supper dramatization.
- Future projects for consideration: 1) refinishing and sealing doors at the Wedemeyer Street entrance; 2) updating the sound system; 3) improving lighting in the back of the sanctuary and in the chancel area in the front of the sanctuary; 4) re-arranging the Gathering Room with the refreshments serving area away from the church office entrance doors; 5) painting selected areas of the church building; 6) creating better signage to rooms in the church building; and 7) deciding what to do with the carillon.

### **Other Business:**

– Discontinue recycling aluminum cans due to low cost of aluminum.

# Learning a Bit More About The United Church of Christ NE Association (Cluster 3)

The Northeast Wisconsin Association is a gathering of 58 United Church of Christ congregations - from Waupun in the southwest to Sheboygan in the southeast to Marinette in the northeast to Shawano in the northwest to Hancock in the west. The congregations vary in size from 43 members to 1800+ members. The Association assists churches who are seeking pastors, oversees students who are preparing for ministry, is a resource for pastors and congregations, plans various programmatic events, administers a budget (supported by dues from each church), and is a liaison between congregations and the wider church. We are a part of Cluster 3, which has 26 congregations. We are allotted three delegates for each of the Associations annual meetings (the last of which was April 22). # **Wisconsin Conference**

Made up of 214 congregations, the Wisconsin Conference cares for all the congregations and their leaders. Some of the ways the conference cares for its congregations is through clergy transition and placement, vision and goal setting, care of congregations, wider church outreach, education, and administration (including healthcare). The conference meets yearly for several days and we are invited to send delegates. Currently, Pastor Jeremy is the only delegate we send. # **General Synod**

The General Synod is the representative body of the United Church of Christ and is composed of delegates chosen by the Conferences, voting members of Boards of Directors of Covenanted Ministries who have been elected by General Synod, and of ex officio delegates. The General Synod adopts a variety of resolutions on church and public matters, with the understanding that the Synod is speaking to the congregations in the UCC, not on behalf of them. This body meets every two years in a different location. In 2017 the synod will be meeting in Baltimore, MD and Pastor Jeremy is one of the delegates for the Wisconsin Conference.
