

Consistory Meeting Minutes - St. Paul's UCC, Sheboygan, WI Wednesday, March 13, 2019 at 6:00 p.m.

Present: Pastor Jeremy Hylen, John Brown, Mike King, Greg Peterson, Deb Severns, Mason White, Joanne Laux and Melody Kolb. **Absent:** Rhoda Cheney and Steve Flook.

Treasurer's Report and Stewardship Report for February 2019 (Greg Peterson): Greg reviewed the reports.

Total Income: \$8,065. Total expenses: \$10,837. Net Income: - \$2,771. General Fund: \$-6,623.

Building Improvement Fund: \$22,360. Parsonage Fund: \$109,510.

Memorial Fund: \$104,170. (Savings Account: \$101,526. Plus, Total Memorial Monies: \$2,643.)

Stewardship Report Weekly Giving Total: \$7,877.

Parsonage Fund reflects the payout from selling the house.

OCWM does not have its own separate envelope for contributions.

Per Deb Severns, the Sunday School balance of \$6,913, does not reflect all for Sunday School. Still have outstanding costs and need to break out portion for Women's Guild from the sale of the cookbooks.

Head Trustee Report (Mason White):

Had enough snow this year. Made six trips for salt.

Plumber coming Friday to work on 3 toilets and a bubbler.

Board of Christian Education Report (Deb Severns):

Spaghetti dinner set for March 24th. Need to get the word out.

Easter Breakfast plans are underway.

Faye's Pizza fundraiser sales are starting.

Pastor's Report (Jeremy Hylen):

Glass in Pastor's office door is being replaced with clear glass. Cost of replacement glass is \$25.

Cost for snow removal in parking lots in consideration for the Last Supper. Was given \$200 per hour.

We will wait to see how the warm weather melts the piles.

Pastor continues to clean storage areas.

The Adult Daycare passed the initial inspection. Two carbon monoxide monitors installed. Hoping to start in May – Monday thru Friday, 8:30 am -3:30 pm.

Applying for WI Conference Grant to be used for new equipment for the Adult Daycare for cabinets.

Looking at getting sanctuary cleaned due to the ice and salt, but waiting until after the Last Supper is done.

Confirmands will give their faith statements to the consistory next month.

Doctrine of Discovery –Pastor to send it to the consistory for review.

Brian and Todd are working on the lights for the Last Supper.

Getting information on the loop system and T-coiled so we can get them to do what they are needed for.

Directory to be done next month per Deb Severns, will be on single page. Shooting to have ready for Easter. Wisconsin UCCE Synod Conference 2019 – Picnic in the park along with Business. Expect 3 to 5 thousand to attend this event. Working on bus transportation. Pastor looking for consideration on behalf of St. Paul's to give a congregational fund of \$500 out of the Endowment or Memorial Fund.

Pastor brought up that St. Paul's does not recycle. Has been taking the recyclables home each week. A recyclable dumpster from Advance Disposal costs \$36 a month. Consistory approved this cost.
