

Can you believe that we are almost into the Lenten season? Starting February 14 with Ash Wednesday (7pm), we will start our journey to Easter. Again this Lenten season, we will be sharing our midweek worship with St. John's U.C.C. at 6:45pm on Thursday nights (Feb 22, March 1, 8, 15, 22). You are invited and encouraged to celebrate your faith with our sister congregation. We will conclude our Lenten journey with Maundy Thursday here at St. Paul's on March 29 (7pm). We will also share Good Friday worship with Ebenezer UCC on March 30 (7pm). And then we wait until Easter morning to celebrate the resurrection with worship and communion at 7:30 am, Easter breakfast starting at 8:30 am, and worship again at 10 am with choir and handbells. I hope all of these opportunities help you deepen your understanding of God's deep and abiding love for you and all of creation.

You can further deepen your Lenten journey by joining us for the Lenten breakfast series on February 21, March 7, and March 21 at 9 am. Another way to explore your faith is to join in bible study. If you are interested in participating in a Lenten study, please let the office know, so we can choose a time that works best so we might further our study of the Gospel of John. And don't forget Messy Church on Wednesday, February 21 at 5 pm in fellowship hall.

Just one year ago, the 5 Practices working group began an exploration to understand our congregation better. After six months of study, prayer, and conversation, our group is ready to begin stage two. We are working with the Wisconsin Conference of the United Church of Christ and the Readiness 360 group to help us with a comprehensive survey of our congregations thinking. This will be emailed out to everyone with email addresses and for those who do not have email, we will have people helping with taking the survey after church. It takes 15-20 minutes (and you can save it and come back later to finish it). The more people who participate, the better our results. The window to participate is February 1 through March 1st. To help you prepare a bit, there will be two long form questions:

What excites you about the possibility of us multiplying our impact through starting a new place or ministry for new people?

What concerns you about the possibility of us multiplying our impact through starting a new place or ministry for new people?

I hope this process will further help us understand how we can best reach out in our neighborhood and community and share the Gospel message of God's love.

- \$2,600 removed from the Parsonage Fund to pay taxes.

- \$10,000 to be moved from the Parsonage Fund to the General Fund to offset deficit (liabilities \$-14,633) Head Trustee Report (Mason White):

- Repair completed on the plumbing fixtures in the men's and women's restrooms adjacent to Fellowship Hall. Additional older plumbing fixtures will be repaired as the need occurs.
- A water leak in the men's restroom adjacent to Fellowship Hall needs maintenance.
- The light on the garage needs maintenance.

## Board of Christian Education Report (Jaymz Stempihar):

- Forthcoming events: Faye's Pizza fundraiser during Lent; Movie Night on March 17; spaghetti dinner on April 15.

- Confirmation classes will end in May.

## Pastor's Report (Jeremy Hylen):

- Sunday school keyboard is broken and needs replacement.
- Memorial donations received from Esther Hemschemeyer family to be used to pay for items on the church wish list.
- Doorbell malfunction in church office being monitored.
- Church membership and email directory information being improved in the church computers.
- Photo directory work resumed and in final stage. Last chance for picture taking during the next few Sundays.
- Paper folder no longer works and needs to be replaced.
- New paper stock for Sunday bulletins needs to be ordered.
- Readiness meeting for "Five Practices Group" upcoming.
- Electronic vote, aka E-vote, is considered to be an important part of Consistory procedures during times when Consistory Meetings are cancelled because of inclement weather and other reasons. The Consistory approved presenting this at the 2017 Annual Congregational Meeting for approval.

## President's Report (Richard Reineking):

- Richard asked what goals/projects to work on during 2018, and it was the consensus of the Consistory
  members present to work on improving the sound system and adding new carpeting to the Sanctuary. Quotes
