

Blue Harbor event set for Sunday, February 16. Have 10 spectators and 38 swimmers.

Looking into mission trips. Working on finding a week everyone is available.

Lent approaching. Worshiping with St. John's UCC on Thursdays. Men's Choir will sing.

Dishwasher in. New countertop to be installed at cost from Damrow. Replacing the faucet and putting a shelf above the dishwasher, just under the cabinet. Pastor found 5 ½ plates and cups.

David Wernecke sings with a Gospel Choir and looking to see if St. Paul's would want to host. Hosting would include site, lunch. There would be a free will offering. We will have the Music Committee review for a possible worship service in the summer.

Carpet: Lyle, Sheboygan Flooring gave us bids. Dulmes comes Monday. It has been suggested to do Gathering Room and hall. Will look at each year to start on other rooms that really need it.

Mission Trip: 4 interested – Different dates. Still looking at options.
